

2026 Saints Game Day Sweepstakes

The 2026 Saints Game Day Sweepstakes ("Sweepstakes") is sponsored by Hancock Whitney Bank ("Sponsor").

The National Football League, its member professional football clubs, NFL Ventures, Inc., Ventures, L.P., NFL Properties LLC, and each of their respective subsidiaries, affiliates, shareholders, officers, directors, agents, representatives and employees (collectively, the "NFL Entities") will have no liability or responsibility for any claims in connection with participation in this Sweepstakes or the prize(s) awarded. The NFL Entities have not offered or sponsored this Sweepstakes in any way. Any questions, comments or complaints regarding the Sweepstakes must be directed to the Sponsor, and not to the NFL Entities.

2. Sweepstakes Period. Begins at 12:01 AM on August 24, 2026 and ends at 11:59 PM on December 4, 2026 ("Sweepstakes Period"). On the Drawing Date(s) noted below, one (1) random drawing for each Saints home game will take place as specified below.

3. Eligibility. The Sweepstakes is subject to applicable federal, state and local laws and regulations. Void where prohibited or restricted by law. Void outside the states listed below.

The Sweepstakes is open to legal residents of Louisiana and Mississippi who have reached the age of majority in their state of domicile at the time of entry. Employees of Sponsor, the New Orleans Louisiana Saints, LLC (the "Saints"), parent companies, subsidiaries, affiliates, prize suppliers and advertising and promotion agencies, and their immediate family members (i.e., spouse and parents, children, siblings

and their respective spouses regardless of where they live) and individuals living in the households of the above, whether related or not, are not eligible to enter or win a prize. Winning a prize is contingent upon fulfilling all requirements set forth herein.

4. How to Enter: There are two ways to enter: (1) You will be automatically entered into the Sweepstakes if you are a current client of Sponsor and complete the entry form at hancockwhitney.com/winsaintstickets-mobile. You can only complete one form every 24 hours.

(2) To enter without purchase or obligation (Non-Purchase Entries): Complete the entry form at hancockwhitney.com/winsaintstickets. You can only complete one form every 24 hours.

Non-winning Sweepstakes entries received for any Sweepstakes Entry Period noted above, will automatically roll-over to be eligible for any remaining subsequent random drawings.

5. Random Drawing(s). One (1) potential winner will be picked for each home game approximately two (2) weeks prior to each home game, and they will be picked among all eligible Automatic Entries and Non-Purchase Entries received. Each potential winner can bring up to up to three (3) guests. Random drawing(s) will be conducted under the direction of Sponsor. The Sponsor's decision(s) are final and binding on matters relating to this Sweepstakes. Potential winner(s) will be notified by telephone and/or email to the phone number or email address associated with the mobile app entry and/or the entry form(s) submitted with the Non-Purchase Entries. Potential winner(s) may be required to verify their eligibility by completing and signing a Liability Waiver, and/or a publicity release (collective, the "Declaration"), and submit the Declaration to Sponsor within three (3) days of notification. Noncompliance with this time frame and/or with these Sweepstakes rules; Sponsor's inability to contact potential winner(s) within a reasonable time period; or prize or prize notification is returned as undeliverable, may result in a potential winner(s)' disqualification and, at Sponsor's discretion, the prize may be awarded to a potential alternate winner. 6. Prizes, Approximate Retail Value ("ARV") and Odds of Winning. Odds of winning a prize depends on the total number of eligible entries received. The odds of an individual's chance of winning will vary based on the level of participation.

The potential winner for each home game will receive four (4) Loge Club tickets and two (2) pre-game sideline passes to the home game for the winner and guests. Each winner and guest(s) will be required to provide their own transportation and accommodations to the home game.

Total ARV of all prizes is \$20,000. Each seat ticket is approximately \$500, and each sideline pass is approximately \$100. Any difference between the stated ARV and the actual value, if any, will not be awarded.

7. Additional Conditions of the Prize. Tickets are subject to certain terms and conditions as specified on the tickets by the NFL and/or issuer. Each winner and guest(s) must comply with all venue, stadium, and event rules and regulations. Failure to do so may result in forfeiture of such portion(s) of prize. Each winner must have a SeatGeek account (SeatGeek.com) in order to receive ticket(s).
